



Call for the assignment of financial contributions to support the enrolment in the Master's Degree Course in Natural Resources Management for Tropical Rural Development for the academic year 2022/2023

The Department of Agriculture, Food, Environment and Forestry (DAGRI) of the University of Florence launches a call for the assignment of financial contributions to support the enrolment in the Master's Degree Course in Natural Resources Management for Tropical Rural Development by university students from Non-European countries for the academic year 2022/2023, who have already obtained clearance in the pre-enrolment phase for the degree course.

The four financial contributions aim at guaranteeing the reimbursement of documented expenses for reaching Florence for the purposes of enrolment at the University of Florence - Master's Degree Course (LM) in Natural Resources Management for Tropical Rural Development (e.g. visa, travel, insurance, residence permit, registration with the National Sanitary Service -SSN). The indicated costs, anticipated by the winner students, will be reimbursed by DAGRI up to a maximum of \notin 700.00 per capita upon verification of the presented documentation. University fees will not be refunded.

Admission requirements. Students of foreign non-European Universities who, on the expiry date of this call for applications, meet the following requirements:

- be born after 31st December 1991
- be non-European citizens and reside in non-European countries

- have obtained the authorization in the pre-enrolment phase for the Degree course in Natural Resources Management for Tropical Rural Development - University of Florence through the portal Universitaly.

Submission of the application. The application form (Application Form link a PDF) must be filled, signed in original by the candidate and sent as PDF file together with a PDF copy of the same identity document used in the pre-registration step, curriculum vitae and a motivation letter.

The application must be received by e-mail not later than 30th June 2022, under penalty of exclusion from the selection procedure.

Candidates who have sent the application after the aforementioned deadline are excluded from participation in the selection.

The application must be sent electronically to the e-mail address: **internationaloffice@dagri.unifi.it**. The message must contain in the subject the words "CALL FOR SELECTION FOR THE AWARD OF ECONOMIC GRANTS TO INCENTIVE ENROLLMENT IN THE MASTER DEGREE COURSE IN NATURAL RESOURCES MANAGEMENT FOR TROPICAL RURAL DEVELOPMENT BY UNIVERSITY STUDENTS FROM EXTRA-EU COUNTRIES FOR THE ACADEMIC YEAR 2022/2023".

Selection of candidates. On the basis of applications received, and after having verified the presence of the regular clearance granted without any training debt for the enrolment to the Master Course and the pre-enrolment on the portal Universitaly by the International Desk;

a Commission of professors nominated by the Director of DAGRI will formulate a ranking of merit taking into account:

- degree mark,
- curriculum vitae,





- motivational letter
- age of the candidate

The first 5 students in the ranking as per the previous phase will be invited to an on-line interview upon prior notice. Upon completion of the selection procedure, a final ranking of the 5 candidates will be drawn up, the first 4 of which will be declared winners.

In case of renunciation, the winner will be nominated according to the ranking until the termination of the same.

The ranking will be announced by July 15 by publication:

- on the website of the University of Florence at the page http://www.unifi.it/albo-ufficiale.html

- on the DAGRI website https://www.dagri.unifi.it/index.php

In case of renouncement by a winning candidate, the ranking will be scrolled to fill the vacant position and new student will be invited to the on-line interview. The Commission's opinion is unquestionable.

Acceptance of the contribution. The winning candidate must formalize the acceptance of the financial contribution within 15 days from the publication of the ranking by email to: internationaloffice@dagri.unifi.it

The winners of this announcement will be able to request reimbursement of eligible expenses starting from September 15th, 2022.

The reimbursement will take place by November 2022 and is subject to the attendance of lessons (minimum attendance rate 60%) in the period September-November 2022 by the winners.

If, after November 30, 2022, unsolicited contribution shares are still available, these will be redistributed among the winners with refund requests exceeding € 700.00

Expenses eligible for reimbursement. Reimbursable expenses, in accordance with the University "Regulations for missions and reimbursement of expenses"(https://www.unifi.it/vp-2344-statuto-e-normativa.html#ateneo), after the presentation of original documentation, up to a maximum total per capita expense of € 700.00:

- Travel expenses to reach Florence;
- Expenses for obtaining the "nulla osta" from the consular authorities for study purposes;
- Expenses for obtaining a residence permit in Italy for study purposes;
- Costs for insurance and registration with the Italian National Sanitary Service (SSN);

Expense receipts (in original) must be delivered to the DAGRI International Office in Piazzale delle Cascine, 18 - 50144 Florence.

The reimbursement will be possible after the completion of the enrolment in the Degree Course in Natural Resources Management for Tropical Rural Development and the attendance of lessons in the period September-November 2022 by the winners.





Treatment of personal data. The personal data transmitted with the request for admission, pursuant to the University Regulations implementing the personal data protection code held by the University of Florence, issued by Rector's decree no. 11777 (79382) of 29 December 2005, will be processed for the purpose of managing the selective procedure. At any time, interested parties may exercise their rights pursuant to the aforementioned Regulation.

Complaints. Any complaints related the procedure of this announcement can be submitted, pursuant to Article 49 of the University Statute, to the Director of the Department within the peremptory deadline of 10 days from publication in the Official University Register.
